Notification of proposed change to the underlying fund of Principal European Responsible Equity (H65) (the "Affected Investment-linked Fund")

We are writing to you as your policy holds units in the above FPIL Affected Investment-linked Fund (the "Affected ILF"). We have been notified by Principal Global Investors (Ireland) Limited (the "Manager") of a proposed change of name to the underlying fund of the Affected ILF. This change is subject to approval by the Central Bank of Ireland (the "CBI"), and if approved will take effect on or about **31 March 2025** (the "**Effective Date**").

Change of name

If CBI approval is received, the Manager has advised that on or around the Effective Date, the underlying fund of the Affected ILF will be renamed from *Principal European Responsible Equity Fund* to *Principal European Equity Fund*. Accordingly, the ILF name will also change on or around the Effective Date as follows:

Reason behind the change

One of the requirements stemming from the European Securities and Markets Authority's *Guidelines on funds'* names using Environmental, Social and Governance ("ESG") or sustainability related terms (the "Guidelines") requires funds using environmental related terms in their name to (i) meet an 80% threshold linked to the proportion of investment used to meet the environmental and/or social characteristics promoted by the fund; and (ii) incorporate the exclusionary criteria for the EU Paris-aligned Benchmarks detailed in Article 12(1)(a) – (g) of Commission Delegated Regulation (EU) 2020/1818 (the "PAB Exclusions").



The Manager is of view that the term *Responsible* in the name of the underlying fund of the Affected ILF could be considered to be an environmental-related term in the context of the underlying fund's investment strategy and bring the underlying fund in scope of the Guidelines. However, as the underlying fund of the Affected ILF does not currently incorporate all of the PAB Exclusions in its investment strategy, the Manager has determined to remove *Responsible* from the name of the underlying fund of the Affected ILF in order to bring it out of scope of the Guidelines.

The Manager has confirmed that the name change will not have any impact on the manner in which the underlying fund is being operated or the overall risk profile.

If the CBI approval is received, this change will happen automatically within your policy or contract and you do not need to take any action. Should the name change not proceed, we will notify you accordingly, after the Effective Date.

Should you wish to switch your existing investment out of the Affected ILF, or to redirect future regular premiums (if any) to a different investment-linked fund, you are free to do so, without charge, by completing a Switch/Redirection instruction form and returning it to our Hong Kong office, a copy of which is available on request.

Please note that you can also switch your investment-linked funds or redirect future premiums at any time, online through the FPI Portal, without charge. Simply log in at https://portal.fpinternational.com. It is a simple, convenient and secure way to manage your policy.

You should read the corresponding offering documents (including Product Key Facts Statement) of the underlying funds (including, without limitation, their investment objectives and policies, risk factors and charges), which will be made available by our Hong Kong office upon request.

有關提議變更信安歐洲責任股票基金 (H65) (「受影響之投資相連基金」)的相關基金通知

我們現向閣下致函,乃因為閣下的保單持有 FPIL 受影響之投資相連基金(「受影響之投資相連基金」)。我 們已收到 Principal Global Investors (Ireland) Limited (以下簡稱「經理」) 通知我們提議變更受影響之投資相 連基金的相關基金的名稱。如果此變更獲得愛爾蘭中央銀行(「CBI」)核准, 則將於 2025 年 3 月 31 日 (「生效日」)或前後生效。

名稱變更

如果獲得 CBI 核准,經理已通知在生效日當天或前後,受影響之投資相連基金的相關基金將從*信安歐洲責任股* 票基金重命名為信安歐洲股票基金。因此,投資相連基金的名稱也將在生效日當天或前後變更如下:

變更決定的理據

歐洲證券及市場管理局關於使用*環境、社會及管治(ESG)或永續發展相關術語的基金名稱指南*(「準則」)的其 中一項要求,名稱中使用環境相關術語的基金必須 (i) 達到 80% 的門檻,該門檻與基金倡導的環境及/或社會特徵 相關的投資比例相關,並 (ii) 納入委員會授權條例 (EU) 2020/1818 第 12(1)(a) - (g) 條詳述的歐盟巴黎協定基準 之排除標準(「PAB 排除」)。



經理認為,受影響之投資相連基金的相關基金的名稱中的「責任」一詞,可視為相關基金投資策略背景下的環境相關術語,並將相關基金納入《準則》範圍。然而,由於受影響之投資相連基金的相關基金目前並未在其投資策略中納入所有 PAB 排除,因此經理已決定從受影響之投資相連基金的相關基金名稱中刪除「*責任*」,以使其脫離準則的範圍。

經理已確認,名稱變更不會對相關基金的營運方式或整體風險概況產生任何影響。

若獲得 CBI 核准,這些變更將在閣下的保單或合約中自動執行,閣下無須採取任何行動。若不繼續進行名稱變更,我們將在生效日後通知閣下。

閣下可隨時將現有的投資從受影響之投資相連基金免費轉換至另一投資相連基金,或將日後的定期保費(如適用)轉換至閣下保單下的另一投資相連基金,費用全免。閣下可向本公司索取基金轉移/重新調配指示表格,並將填妥的表格交回我們的香港辦事處。
